**Expression of Interest (E-PROCUREMENT) For Selection of Concessionaire
(Third Round Bidding)**

This has reference to RFQ application notice no. 1147/Pravi-(PGB Con. Sel. Vol-2) /2020-21/UPSHA/Lucknow Dated: 21-02-2021 for selection of Concessionaire on DBFOT basis for Upgradation of Pukhrayan-Ghatampur-Bindaki Road (SH-46). Following Bidders are eligible to participate in third round bidding process ("Bid Stage") i.e. Request for Proposal (The "RFP") based on their short listing in RFQ stage :-

Online RFP is invited from all the above short listed bidders for the Third Round of Bidding. The bidding documents may be purchased from the office of U.P. State Highways Authority, Lucknow from 07 September, 2022 to 06 October 2022 on all working days from 11:00 hrs. to 17:00 hrs. on payment of Rs.4,54,500/- (Rs. Four Lacs Fifty Four Thousand Five Hundred only)+ GST, as applicable in the form of Demand Draft in favour of Chief Executive Officer, U.P. State Highways Authority, payable at Lucknow. The details of the bidding process are mentioned in RFP document. The schedule of bidding process is as below:-

- (1) The Bid document will be available on website:- <http://etender.up.nic.in> from 07 September, 2022 to 06 October 2022 up to 15:00 Hours which can be downloaded from the website.
- (2) Proposal may be uploaded by the above selected eligible bidders only on the above website on or before 07 October, 2022 at 15:00 Hrs.
- (3) Pre-Bid Meeting will be held in the office of UPSHA on 20 September, 2022 or as notified by UPSHA and outcome will be hosted on website as Addendum.
- (4) Financial Bid of bidders will be opened online in the office of UPSHA:- **07 October, 2022 at 16:00 Hours in the presence of PPP BEC.**
- (5) Scanned copy of the Cost of the RFP documents and Bid security in the form of Bank Draft issued by Nationalized bank in the favour of "Chief Executive Officer, Uttar Pradesh State Highways Authority" Payable at Lucknow shall be uploaded along with tender document.
- (6) Original Copy of the RFP documents and cost of the tender documents/Bid security as specified in RFP shall be submitted in the office of UPSHA on or before opening of the Financial Bid. If Bid security is already submitted, the bidders are required to revalidate or extend their bid security, as the case may be.
- (7) For Financial Bid Evaluation, documents submitted online shall only be considered.
- (8) Registration on above website by bidders is compulsory. For tendering online bidders should have digital signature certificate issued by certifying Authority.
- (9) Amendments/Corrigendum/Notification, if any, will be hosted on the Authority website only.
