## EXPRESSION OF INTEREST (E-PROCUREMENT)

Uttar Pradesh State Highways Authority (UPSHA) is engaged in the development of highways in Uttar Pradesh through Public-Private-Partnership (PPP) on Design, Build, Finance, Operate and Transfer (DBFOT) basis.

With a view to invites bids for the following projects, the Authority has decided to conduct feasibility study for determining the technical feasibility and financial viability of the each projects. If found technically feasible and financial viable the project may be awarded on DBFOT basis to a private entity (the Concessionaire) selected through a competitive bidding process.

In pursuant of above Authority invites proposal for selection of technical consultant who shall prepare a feasibility report in accordance with the terms of reference specified at schedule 1 (the ToR). The feasibility report shall include traffic and engineering survey, alignment review, land plans and preliminary design of geometrics, pavement, structures, safety devices, toll plazas and project facilities and cost estimates and other documents in conformity with ToR. The Authority intents to select the consultants for each projects through and open compctitive process in accordance with the procedure set out herein.
